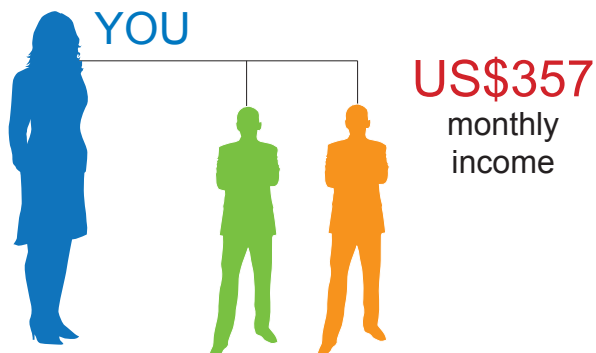

Repeat Part One four times.**



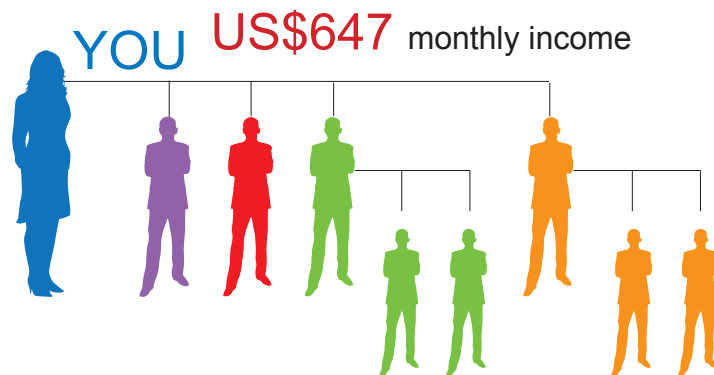
Duplicate: Find two IBAs who become Jump Starts

Congratulations! You earn US\$611 in First Order Bonuses and commissions. Maintain your network at this level each month and your monthly commissions will be US\$357 a month.

Each person represents 100 BV IBA AS and 700 BV PC sales.

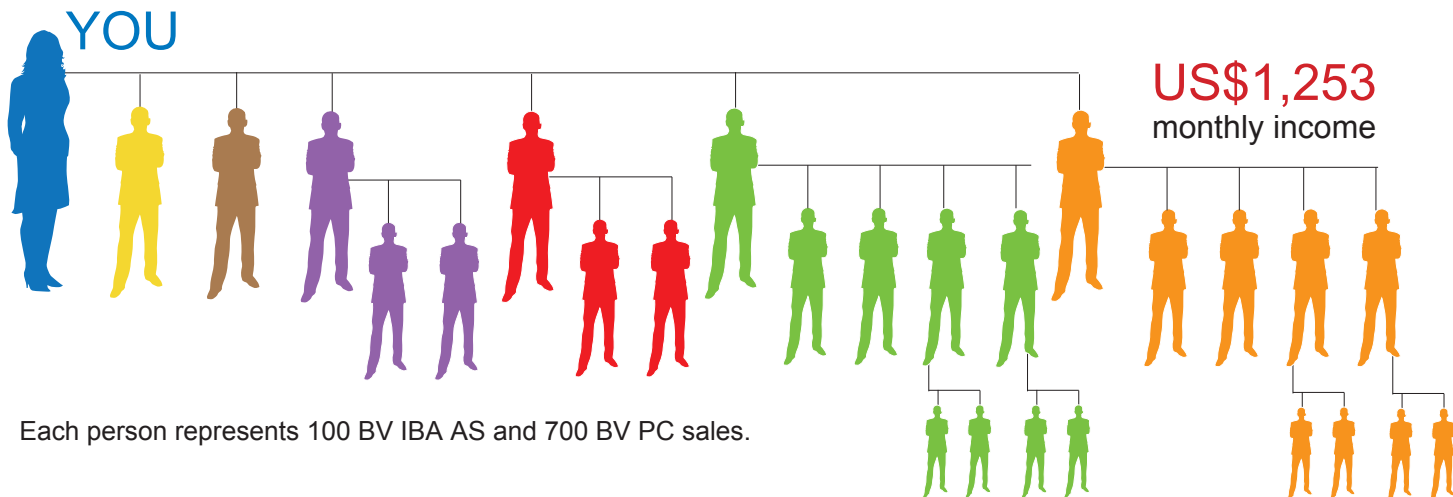
Leverage: You continue to duplicate by finding two more IBAs who Jump Start AND teach your IBAs to do the same thing.

You have earned US\$957 in First Order Bonuses and commissions. Maintain this level of business and you will earn US\$647 in residual income each month.

Average Earnings Disclosure for the period August 2008 to July 2009: 29% of SH IBAs are active (earning income), with an average monthly earnings of US\$153.96 and annual earnings of US\$1,847.56. 11.51% earned more than US\$191/month, 6.85% earned more than US\$357/month, 3.93% earned more than US\$647/month and 2.03% earned more than US\$1,253/month.
